I am aware that the use of the activities made available in the trampoline arena generally involves dangers and risks. A degree of physical fitness is required. I declare that I have familiarized myself with the safety instructions and jumping rules and accept them as binding.

In addition, I will immediately comply with all instructions of the operator or his staff. I am aware that if I fail to observe the attachment, I may be relieved of any claim for reimbursement of the entrance fee.

The use of the arena is at your own risk. I am aware that the operator assumes liability for personal, material or pecuniary damage - except for damages resulting from injury to life, body and health - only in the case of intent or gross negligence of the operator, a legal representative or one of his vicarious agents.

I am aware that the operator assumes no liability for the cloakroom or other objects of the user in case of loss or damage, as far as the damages are not based on an intentional or grossly negligent breach of duty of the operator, a legal representative or one of his vicarious agents. This also applies to vehicles parked in the parking lots.

The operator is not liable for force majeure and coincidence as well as for defects which are not recognized immediately even if the usual care is taken.

I declare that I am responsible for any damage to the equipment or objects of the operator or third parties or the health of third parties caused by me, my children or the supervised children.
